5. Seller agrees that Maynard's Auction Service Inc. assumes no liability for loss or damages to the vehicle, and seller agrees to hold Maynard's Auction Service Inc. Agents or Employees harmless from any claims for bodily injury or property damage arising from said auction sale. I acknowledge that Maynard's Auction service Inc. is neither the seller nor the buyer in any transaction and Maynard's Auction Service Inc. is acting only as the agent of the sale. I agree to hold harmless Maynard's Auction Service Inc. its Agents, Employees and Officers from any claims of loss or liability, errors or omissions that may arise from any sale or purchases.
